HISTORY AND BACKGROUND OF THE JOURNAL OF AMERICAN GERIATRIC SOCIETY

IT IS PUBLISHED MONTHLY AND SERVES AS THE OFFICIAL PUBLICATION OF THE AMERICAN GERIATRICS SOCIETY (AGS), A PROMINENT PROFESSIONAL ORGANIZATION COMMITTED TO IMPROVING THE CARE OF OLDER PERSONS.
