## HISTORY AND BACKGROUND

THE **JOURNAL OF AMERICAN MATHEMATICAL SOCIETY** WAS FIRST PUBLISHED IN 1988 BY THE AMERICAN MATHEMATICAL SOCIETY (AMS) TO PROVIDE A HIGH-QUALITY OUTLET FOR ORIGINAL RESEARCH PAPERS IN ALL AREAS OF PURE AND APPLIED MATHEMATICS. SINCE ITS INCEPTION, THE JOURNAL HAS MAINTAINED A REPUTATION FOR PUBLISHING PAPERS OF EXCEPTIONAL SIGNIFICANCE AND ORIGINALITY. ITS ESTABLISHMENT AIMED TO MEET THE GROWING NEED FOR A COMPREHENSIVE JOURNAL THAT COULD REPRESENT THE DIVERSE FIELDS WITHIN MATHEMATICS WHILE UPHOLDING RIGOROUS ACADEMIC STANDARDS.

## FOUNDING PRINCIPLES

## EMPHASIS ON ORIGINALITY AND DEPTH

## SUBMISSION REVIEW WORKFLOW

WHEN A MANUSCRIPT IS SUBMITTED, IT UNDERGOES A PRELIMINARY EVALUATION BY THE EDITORIAL BOARD TO ASSESS ITS SUITABILITY FOR THE JOURNAL'S SCOPE AND STANDARDS. SUITABLE MANUSCRIPTS ARE THEN SENT TO EXPERT REFEREES FOR A RIGOROUS PEER REVIEW PROCESS, TYPICALLY INVOLVING MULTIPLE REVIEWERS TO ENSURE FAIRNESS AND THOROUGHNESS.

## CRITERIA FOR PEER REVIEW

REVIEWERS EVALUATE SUBMISSIONS BASED ON ORIGINALITY, CORRECTNESS, SIGNIFICANCE, CLARITY, AND COMPLETENESS. THE JOURNAL VALUES CONSTRUCTIVE FEEDBACK AND ENCOURAGES REVIEWERS TO PROVIDE DETAILED REPORTS THAT HELP AUTHORS IMPROVE THEIR WORK. THIS PROCESS ENSURES THE JOURNAL'S CONTENT REMAINS RELIABLE AND INFLUENTIAL.

SUBMISSIONS SHOULD BE FORMATTED ACCORDING TO THE AMS STYLE, WHICH INCLUDES CLEAR MATHEMATICAL NOTATION, STRUCTURED ABSTRACTS, AND COMPREHENSIVE REFERENCES. THE JOURNAL ENCOURAGES AUTHORS TO PROVIDE SUPPLEMENTARY MATERIAL SUCH AS PROOFS AND DATA SETS WHEN APPROPRIATE.

## REVIEW TIMELINE AND DECISIONS

THE REVIEW PROCESS TYPICALLY TAKES SEVERAL MONTHS, DEPENDING ON REVIEWER AVAILABILITY AND THE COMPLEXITY OF THE MANUSCRIPT. AUTHORS RECEIVE DECISIONS RANGING FROM ACCEPTANCE WITH MINOR REVISIONS TO REJECTION. THE EDITORIAL TEAM STRIVES FOR TRANSPARENCY AND CONSTRUCTIVE COMMUNICATION THROUGHOUT THIS PROCESS.

## PUBLICATION AND DISSEMINATION

ACCEPTED PAPERS ARE PUBLISHED BOTH IN PRINT AND ONLINE, ENSURING WIDE ACCESSIBILITY. THE JOURNAL ALSO PARTICIPATES IN INDEXING SERVICES THAT ENHANCE THE VISIBILITY AND DISCOVERABILITY OF ITS ARTICLES.
