4. DIAGNOSTIC TEST RESULTS

MEDICAL RECORDS ALSO INCLUDE RESULTS FROM VARIOUS DIAGNOSTIC TESTS, SUCH AS:

- LABORATORY TESTS (BLOOD TESTS, URINE TESTS, ETC.)
