DUTIES AND RESPONSIBILITIES

Work Settings

MEDICATION AIDES COMMONLY WORK IN ENVIRONMENTS SUCH AS NURSING HOMES, REHABILITATION CENTERS, ASSISTED LIVING FACILITIES, AND HOME HEALTH CARE. EACH SETTING MAY HAVE SPECIFIC PROTOCOLS AND MEDICATION POLICIES THAT AIDES MUST FOLLOW CLOSELY.

Certification Requirements and Eligibility

Certification Exam
