- BLOOD BANKING AND TRANSFUSION MEDICINE – PROCEDURES RELATED TO BLOOD TYPING AND TRANSFUSIONS.
- CLINICAL MICROSCOPY – ANALYSIS OF URINE AND OTHER BODY FLUIDS.
- LABORATORY MANAGEMENT AND SAFETY – OPERATIONAL PROTOCOLS AND QUALITY CONTROL.

EXAM STRUCTURE

THE EXAM IS USUALLY DIVIDED INTO TWO PARTS, ADMINISTERED OVER SEVERAL DAYS. THE FIRST PART INCLUDES WRITTEN MULTIPLE-CHOICE QUESTIONS AND PROBLEM-SOLVING EXERCISES COVERING ALL THE MAJOR SUBJECTS. THE SECOND PART MAY INVOLVE PRACTICAL ASSESSMENTS OR ORAL EXAMINATIONS, DEPENDING ON THE SPECIFIC GUIDELINES FOR THE YEAR.
