HISTORICAL STALKERS AND THEIR IMPACT

CASE OF EDWARD II AND PIERS GAVESTON

ONE OF THE EARLIEST RECORDED INSTANCES RESEMBLING STALKING WAS THE RELATIONSHIP BETWEEN KING EDWARD II OF ENGLAND AND HIS FAVORITE, PIERS GAVESTON. WHILE NOT A CASE OF STALKING IN THE MODERN LEGAL SENSE, EDWARD'S OBSESSIVE ATTENTION AND FAVORITISM TOWARDS GAVESTON SPARKED INTENSE RESENTMENT AND POLITICAL TURMOIL, ILLUSTRATING EARLY EXAMPLES OF OBSESSION CAUSING REAL-WORLD CONSEQUENCES.

HISTORIC OBSESSIONS IN ROYAL COURTS

ROYAL COURTS ACROSS EUROPE WERE RIFE WITH STORIES OF OBSESSIVE ADMIRERS AND JEALOUS RIVALS WHOSE ACTIONS SOMETIMES ESCALATED TO DANGEROUS LEVELS. ROBERT JOHN BARDO AND REBECCA SCHAEFFER

ROBERT JOHN BARDO IS ONE OF THE MOST NOTORIOUS CELEBRITY STALKERS IN MODERN HISTORY. HIS OBSESSION WITH ACTRESS REBECCA SCHAEFFER ENDED TRAGICALLY IN 1989 WHEN HE MURDERED HER. THIS CASE LED TO SIGNIFICANT CHANGES IN LAWS RELATED TO STALKING AND THE IMPLEMENTATION OF PROTECTIVE MEASURES FOR CELEBRITIES AND THE PUBLIC ALIKE.

JOHN HINCKLEY JR. AND JODIE FOSTER

ANOTHER HIGH-PROFILE CASE INVOLVED JOHN HINCKLEY JR., WHO STALKED ACTRESS JODIE FOSTER IN AN ATTEMPT TO GAIN HER ATTENTION. HIS OBSESSION CULMINATED IN THE ATTEMPTED ASSASSINATION OF PRESIDENT RONALD REAGAN IN 1981, HIGHLIGHTING THE POTENTIAL DANGERS STALKING CAN POSE BEYOND THE VICTIM.

ELVIS PRESLEY AND FAN STALKERS

ELVIS PRESLEY, ONE OF THE MOST FAMOUS ENTERTAINERS IN HISTORY, EXPERIENCED NUMEROUS STALKING INCIDENTS BY OVERZEALOUS FANS. THESE CASES ILLUSTRATE THE CHALLENGES CELEBRITIES FACE IN MAINTAINING PERSONAL SAFETY AND PRIVACY AMIDST INTENSE PUBLIC ATTENTION.

PSYCHOLOGICAL PROFILES OF NOTORIOUS STALKERS

LEGAL RESPONSES TO STALKING THROUGH THE YEARS

CHRISTOPHER WATTS AND PETITIONS AGAINST CELEBRITIES

WHILE NOT A TRADITIONAL STALKER, CHRISTOPHER WATTS EXHIBITED STALKING-LIKE BEHAVIORS IN HIS FIXATION ON CERTAIN PUBLIC FIGURES. MODERN TECHNOLOGY HAS ALSO FACILITATED NEW FORMS OF STALKING, SUCH AS CYBERSTALKING, WHICH POSE UNIQUE CHALLENGES TO LAW ENFORCEMENT.
