THE FOUR LEVELS OF READING ACCORDING TO MORTIMER J. ADLER

MORTIMER J. ADLER'S CONCEPT OF READING IS STRUCTURED AROUND FOUR DISTINCT LEVELS, EACH DESIGNED TO DEEPEN THE READER'S UNDERSTANDING AND ENGAGEMENT WITH THE TEXT. ELEMENTARY READING

SYNTOPICAL READING

IT ENABLES READERS TO CONSTRUCT THEIR OWN UNDERSTANDING BY INTEGRATING DIVERSE PERSPECTIVES.

ACTIVE READING TECHNIQUES AND STRATEGIES

USING QUESTIONS TO GUIDE READING
