 - NATIONAL PORTION: 80 QUESTIONS
 - STATE PORTION: 40 QUESTIONS
2. **TIME LIMIT:** CANDIDATES ARE USUALLY ALLOTTED A TOTAL OF 4 HOURS TO COMPLETE BOTH PORTIONS.

- GATHER REQUIRED MATERIALS: ENSURE YOU HAVE A VALID ID, ANY REQUIRED DOCUMENTATION, AND MATERIALS ALLOWED DURING THE EXAM (E.G., CALCULATOR).
- KNOW THE EXAM LOCATION: FAMILIARIZE YOURSELF WITH THE TESTING CENTER'S LOCATION AND PLAN TO ARRIVE EARLY.

AFTER THE EXAM

IS THERE A TIME LIMIT ON HOW LONG I HAVE TO PASS THE MISSISSIPPI REAL ESTATE LICENSE EXAM AFTER COMPLETING MY COURSEWORK?

YES, YOU MUST PASS THE MISSISSIPPI REAL ESTATE LICENSE EXAM WITHIN ONE YEAR OF COMPLETING YOUR PRE-LICENSING COURSEWORK.
