UNDERSTANDING THE NC REAL ESTATE EXAM STRUCTURE

THE NORTH CAROLINA REAL ESTATE EXAM IS DESIGNED TO EVALUATE THE CANDIDATE'S KNOWLEDGE OF REAL ESTATE PRINCIPLES, PRACTICES, AND LEGAL REQUIREMENTS SPECIFIC TO THE STATE.
