HISTORY AND MISSION OF THE NATIONAL FEDERAL OF INDEPENDENT BUSINESS

THE NATIONAL FEDERAL OF INDEPENDENT BUSINESS WAS FOUNDED IN 1943 WITH THE PRIMARY GOAL OF PROVIDING SMALL BUSINESS OWNERS WITH A COLLECTIVE VOICE IN THE POLITICAL AND ECONOMIC ARENAS. OVER THE DECADES, NFIB HAS GROWN TO BECOME ONE OF THE LARGEST ADVOCACY GROUPS REPRESENTING SMALL BUSINESSES IN THE UNITED STATES. THE ORGANIZATION'S MISSION CENTERS AROUND PROMOTING AND PROTECTING THE RIGHT OF SMALL BUSINESS OWNERS TO OWN, OPERATE, AND GROW THEIR ENTERPRISES WITH MINIMAL GOVERNMENT INTERFERENCE.

NFIB'S MISSION IS DEEPLY ROOTED IN ENSURING THAT THE ENTREPRENEURIAL SPIRIT THRIVES BY INFLUENCING PUBLIC POLICY AND PROVIDING MEMBERS WITH TOOLS TO SUCCEED. THE ORGANIZATION EMPHASIZES THE IMPORTANCE OF FREE ENTERPRISE AND WORKS TO REDUCE REGULATORY BURDENS, LOWER TAXES, AND IMPROVE ACCESS TO CAPITAL FOR INDEPENDENT BUSINESSES.

ADVOCACY AND LEGISLATIVE INFLUENCE

ONE OF THE DEFINING CHARACTERISTICS OF THE NATIONAL FEDERAL OF INDEPENDENT BUSINESS IS ITS POWERFUL ADVOCACY EFFORTS AT THE FEDERAL, STATE, AND LOCAL LEVELS.
