- TRAUMA PATIENT ASSESSMENT/MANAGEMENT: CANDIDATES PERFORM A RAPID TRAUMA ASSESSMENT, MANAGE SPINAL PRECAUTIONS, AND TREAT INJURIES ACCORDING TO PROTOCOL.
- MEDICAL PATIENT ASSESSMENT/MANAGEMENT: THIS SCENARIO INVOLVES ASSESSING AND MANAGING MEDICAL EMERGENCIES SUCH AS RESPIRATORY DISTRESS, DIABETIC EMERGENCIES, OR SEIZURES.

TIME AND FORMAT

EACH SKILL STATION USUALLY ALLOWS BETWEEN 8 TO 15 MINUTES FOR COMPLETION, DEPENDING ON THE COMPLEXITY OF THE TASK. CANDIDATES MUST FOLLOW STANDARDIZED PROCEDURES AND DEMONSTRATE CORRECT TECHNIQUE AND DECISION-MAKING THROUGHOUT. THE EXAM IS CONDUCTED IN A CONTROLLED ENVIRONMENT WITH CERTIFIED EXAMINERS OBSERVING AND SCORING PERFORMANCE BASED ON ESTABLISHED CRITERIA.

PREPARATION STRATEGIES FOR SUCCESS
