- **GRANTS:** NEED-BASED FINANCIAL AID THAT DOES NOT NEED TO BE REPAYED.

KEY DATES FOR FINANCIAL AID DISBURSEMENT IN 2023

THE DISBURSEMENT OF FINANCIAL AID TYPICALLY OCCURS AT THE BEGINNING OF EACH ACADEMIC TERM. HOWEVER, THE SPECIFIC DATES CAN VARY BY INSTITUTION. HERE ARE SOME KEY DATES AND FACTORS TO CONSIDER:

FALL SEMESTER DISBURSEMENT

MOST UNIVERSITIES DISBURSE FINANCIAL AID FOR THE FALL SEMESTER IN LATE AUGUST OR EARLY SEPTEMBER. HERE'S A GENERAL TIMELINE:

1. DECEMBER 1-15: NOTIFICATIONS ARE SENT OUT FOR SPRING FINANCIAL AID.
2. DECEMBER 15-30: STUDENTS COMPLETE ANY REQUIRED DOCUMENTATION.
3. JANUARY 1: DISBURSEMENT OF FINANCIAL AID BEGINS.

SUMMER SESSION DISBURSEMENT

SUMMER FINANCIAL AID DISBURSEMENT VARIES WIDELY ACROSS INSTITUTIONS. SOME MAY DISBURSE FUNDS AT THE START OF THE SUMMER TERM, WHILE OTHERS MAY DO SO AT THE BEGINNING OF EACH SUMMER SESSION. HERE'S A TYPICAL TIMELINE:

1. MAY 1-15: NOTIFICATIONS FOR SUMMER FINANCIAL AID ARE SENT.
2. MAY 15-30: STUDENTS COMPLETE NECESSARY DOCUMENTATION.
3. JUNE 1: DISBURSEMENT BEGINS.

FACTORS AFFECTING DISBURSEMENT DATES

CHECKING YOUR FINANCIAL AID STATUS

STUDENTS SHOULD REGULARLY CHECK THEIR FINANCIAL AID STATUS THROUGH THEIR UNIVERSITY'S FINANCIAL AID OFFICE. MOST UNIVERSITIES HAVE ONLINE PORTALS WHERE STUDENTS CAN:

- VIEW THEIR FINANCIAL AID AWARDS.
- CHECK FOR ANY OUTSTANDING REQUIREMENTS.
- CONFIRM DISBURSEMENT DATES AND AMOUNTS.

CONTACTING FINANCIAL AID OFFICES

IF THERE ARE ANY QUESTIONS REGARDING FINANCIAL AID DISBURSEMENT, STUDENTS ARE ENCOURAGED TO CONTACT THEIR UNIVERSITY'S FINANCIAL AID OFFICE DIRECTLY. HERE ARE SOME TIPS FOR EFFECTIVE COMMUNICATION:

1. PREPARE DOCUMENTS: HAVE YOUR STUDENT ID AND ANY RELEVANT FINANCIAL DOCUMENTS ON HAND.
2. BE SPECIFIC: CLEARLY STATE YOUR QUESTION OR CONCERN REGARDING DISBURSEMENT DATES.
3. FOLLOW UP: IF YOU DO NOT RECEIVE A TIMELY RESPONSE, DON'T HESITATE TO FOLLOW UP.

TIPS FOR MANAGING FINANCIAL AID

TO MAKE THE MOST OF FINANCIAL AID, STUDENTS SHOULD CONSIDER THE FOLLOWING TIPS:

CREATE A BUDGET

DEVELOPING A BUDGET CAN HELP STUDENTS MANAGE THEIR FINANCES EFFECTIVELY. CONSIDER THE FOLLOWING EXPENSES:

- TUITION AND FEES
- ROOM AND BOARD
- TEXTBOOKS AND SUPPLIES
- PERSONAL EXPENSES

A WELL-STRUCTURED BUDGET CAN HELP STUDENTS ALLOCATE THEIR FINANCIAL AID EFFECTIVELY AND AVOID OVERSPENDING.

UNDERSTAND LOAN TERMS

IF A PORTION OF FINANCIAL AID COMES IN THE FORM OF LOANS, IT'S CRUCIAL TO UNDERSTAND THE TERMS, INCLUDING INTEREST RATES, REPAYMENT PLANS, AND DEFERMENT OPTIONS. FAMILIARIZE YOURSELF WITH THE FOLLOWING:

1. FEDERAL VS. PRIVATE LOANS: KNOW THE DIFFERENCES IN TERMS AND CONDITIONS.
2. REPAYMENT PLANS: EXPLORE OPTIONS THAT BEST FIT YOUR FINANCIAL SITUATION.
3. LOAN FORGIVENESS PROGRAMS: RESEARCH POTENTIAL ELIGIBILITY FOR FORGIVENESS PROGRAMS BASED ON YOUR CAREER PATH.

MONITOR YOUR ACADEMIC PROGRESS

MANY FINANCIAL AID PROGRAMS REQUIRE STUDENTS TO MAINTAIN SATISFACTORY ACADEMIC PROGRESS (SAP). THIS OFTEN INCLUDES MAINTAINING A CERTAIN GPA AND COMPLETING A SPECIFIC PERCENTAGE OF ENROLLED COURSES.

ARE THERE ANY ELIGIBILITY REQUIREMENTS FOR FINANCIAL AID DISBURSEMENT AT NATIONAL UNIVERSITY?

YES, TO BE ELIGIBLE FOR FINANCIAL AID DISBURSEMENT AT NATIONAL UNIVERSITY, STUDENTS MUST MEET CERTAIN CRITERIA, INCLUDING MAINTAINING SATISFACTORY ACADEMIC PROGRESS, BEING ENROLLED IN AN ELIGIBLE PROGRAM, AND COMPLETING ALL REQUIRED PAPERWORK.

HOW WILL I RECEIVE MY FINANCIAL AID DISBURSEMENT FROM NATIONAL UNIVERSITY?

FINANCIAL AID DISBURSEMENTS AT NATIONAL UNIVERSITY ARE USUALLY CREDITED DIRECTLY TO THE STUDENT'S TUITION ACCOUNT. ANY REMAINING FUNDS MAY BE ISSUED TO THE STUDENT VIA CHECK OR DIRECT DEPOSIT, DEPENDING ON THE STUDENT'S PREFERENCES SET IN THEIR FINANCIAL ACCOUNT.
