THE MISSION SHOULD HIGHLIGHT CORE VALUES AND SPECIFIC GOALS, SUCH AS RESCUING ABANDONED ANIMALS, PROVIDING MEDICAL CARE, AND PROMOTING ADOPTION. IT MUST RESONATE WITH DONORS, VOLUNTEERS, AND COMMUNITY MEMBERS.

VISION STATEMENT

THE VISION SHOULD ARTICULATE THE ULTIMATE IMPACT, SUCH AS CREATING A COMMUNITY WHERE ALL ANIMALS ARE SAFE AND CARED FOR, AND RAISING AWARENESS ABOUT ANIMAL WELFARE ISSUES.

CONDUCTING MARKET AND COMMUNITY ANALYSIS

MARKET AND COMMUNITY ANALYSIS IS AN ESSENTIAL PART OF THE NON PROFIT ANIMAL RESCUE BUSINESS PLAN TEMPLATE.
