

NON CUSTODIAL PARENT BLOCKING COMMUNICATION

IN SOME CASES, COMMUNICATION BLOCKING MAY BE UNINTENTIONAL, RESULTING FROM LOGISTICAL CHALLENGES OR POOR COMMUNICATION HABITS.

COMMON CAUSES OF COMMUNICATION BLOCKING

FORMS OF COMMUNICATION BLOCKING

BLOCKING CAN MANIFEST IN VARIOUS WAYS, SUCH AS:

- IGNORING OR REFUSING INCOMING CALLS AND MESSAGES.
- RESTRICTING OR SUPERVISING ALL COMMUNICATION CHANNELS.
- INTERFERING WITH SCHEDULED VISITS OR EXCHANGES.
- USING CHILDREN AS INTERMEDIARIES TO RELAY MESSAGES SELECTIVELY.
- DELIBERATELY PROVIDING FALSE INFORMATION ABOUT COMMUNICATION ATTEMPTS.

LEGAL IMPLICATIONS AND RIGHTS

LEGAL FRAMEWORKS RECOGNIZE THE IMPORTANCE OF MAINTAINING PARENT-CHILD RELATIONSHIPS AND TYPICALLY SUPPORT THE NON CUSTODIAL PARENT'S RIGHT TO COMMUNICATE WITH THEIR CHILD. BLOCKING COMMUNICATION WITHOUT VALID REASONS CAN VIOLATE CUSTODY AGREEMENTS OR COURT ORDERS. UNDERSTANDING THE LEGAL RIGHTS AND RESPONSIBILITIES OF EACH PARENT IS CRUCIAL WHEN ADDRESSING COMMUNICATION BARRIERS.

CUSTODY AND VISITATION ORDERS

EXCEPTIONS AND CONSIDERATIONS

- VERIFIED CONCERNS OF CHILD ABUSE OR NEGLECT.
- PROTECTIVE ORDERS ISSUED FOR SAFETY REASONS.

- AGREED-UPON LIMITS TO PROTECT THE CHILD'S WELL-BEING.

COURTS PRIORITIZE THE BEST INTERESTS OF THE CHILD, BALANCING PARENTAL RIGHTS WITH SAFETY AND STABILITY.

IMPACT ON CHILDREN
