ADDITIONALLY, APPLICANTS MUST NOT HAVE BEEN CONVICTED OF A FELONY OR CERTAIN MISDEMEANORS THAT COULD DISQUALIFY THEM FROM SERVING AS A NOTARY. THE COMMISSION PERIOD FOR OHIO NOTARIES IS TYPICALLY FIVE YEARS, AFTER WHICH RENEWAL IS NECESSARY. REMAINING CURRENT WITH COMMISSIONS ENSURES THE LEGALITY OF ALL NOTARIZED DOCUMENTS.

UNDERSTANDING THE NOTARY PRACTICE TEST OHIO
