## LICENSING REQUIREMENTS IN NEW YORK STATE

BEFORE YOU CAN START WORKING AS A PRIVATE INVESTIGATOR IN NYS, YOU MUST OBTAIN A LICENSE. THE REQUIREMENTS INCLUDE:

1. ELIGIBILITY:
  - BE AT LEAST 25 YEARS OLD.
  - HAVE A HIGH SCHOOL DIPLOMA OR EQUIVALENT.
  - BE A U.S. CITIZEN OR LEGAL RESIDENT.
2. EXPERIENCE:
  - FIVE YEARS OF EXPERIENCE IN INVESTIGATIVE WORK OR A COMBINATION OF EDUCATION AND EXPERIENCE.
  - RELEVANT DEGREES (E.G., CRIMINAL JUSTICE, SECURITY MANAGEMENT) CAN SUBSTITUTE FOR UP TO THREE YEARS OF EXPERIENCE.
3. APPLICATION PROCESS:
  - SUBMIT A COMPLETED APPLICATION TO THE NEW YORK STATE DEPARTMENT OF STATE.
  - PAY THE REQUIRED FEE (AS OF 2023, THE FEE IS \$10 FOR THE APPLICATION).
  - PROVIDE PROOF OF EXPERIENCE AND EDUCATION.
4. BACKGROUND CHECK:
  - UNDERGO A CRIMINAL BACKGROUND CHECK TO ENSURE YOU HAVE NO FELONY CONVICTIONS.
5. EXAMINATION:
  - PASS THE NEW YORK STATE PRIVATE INVESTIGATOR EXAM, WHICH TESTS YOUR KNOWLEDGE OF RELEVANT LAWS AND INVESTIGATIVE TECHNIQUES.

## CORE TOPICS TO STUDY FOR THE EXAM

- UNDERSTAND THE POTENTIAL RISKS INVOLVED IN INVESTIGATIVE WORK AND STRATEGIES TO MITIGATE THEM.
- LEARN ABOUT PERSONAL SAFETY MEASURES WHEN CONDUCTING SURVEILLANCE AND INTERACTING WITH SUBJECTS.

4. **BUILD YOUR BUSINESS:** IF YOU PLAN TO WORK INDEPENDENTLY, CREATE A BUSINESS PLAN, ESTABLISH A MARKETING STRATEGY, AND NETWORK TO BUILD A CLIENT BASE.
