## UNDERSTANDING SWOT ANALYSIS IN NURSING

THE ACRONYM SWOT STANDS FOR STRENGTHS, WEAKNESSES, OPPORTUNITIES, AND THREATS. STRENGTHS AND WEAKNESSES ARE INTERNAL FACTORS THAT NURSES OR HEALTHCARE TEAMS CAN CONTROL OR INFLUENCE. OPPORTUNITIES AND THREATS ARE EXTERNAL FACTORS THAT ARISE FROM THE HEALTHCARE INDUSTRY, REGULATORY CHANGES, OR PATIENT DEMOGRAPHICS.

USING A NURSING SWOT ANALYSIS EXAMPLE ALLOWS PROFESSIONALS TO SYSTEMATICALLY EVALUATE THEIR CURRENT STATUS AND DEVELOP STRATEGIC PLANS TO IMPROVE NURSING CARE DELIVERY AND PROFESSIONAL GROWTH.

## STRENGTHS IN NURSING SWOT ANALYSIS
