DOCUMENTATION AND VERIFICATION

APPLICANTS MAY BE REQUIRED TO PROVIDE DOCUMENTATION SUPPORTING THEIR RECOVERY STATUS AND EDUCATIONAL BACKGROUND. VERIFICATION OF RECOVERY OFTEN INVOLVES LETTERS OF RECOMMENDATION FROM TREATMENT PROVIDERS, SPONSORS, OR OTHER RECOVERY COMMUNITY MEMBERS. THESE MEASURES AIM TO UPHOLD THE INTEGRITY AND PROFESSIONALISM OF PEER RECOVERY SPECIALIST SERVICES.

CORE CURRICULUM AND TRAINING COMPONENTS
