PHD IN OCCUPATIONAL THERAPY IS AN ADVANCED ACADEMIC DEGREE DESIGNED FOR INDIVIDUALS WHO ASPIRE TO CONTRIBUTE TO THE FIELD OF OCCUPATIONAL THERAPY THROUGH RESEARCH, EDUCATION, AND LEADERSHIP. CURRICULUM AND REQUIREMENTS FOR A PHD IN OCCUPATIONAL THERAPY
