OVERVIEW OF THE PEDIATRIC BOARD EXAM

THE PEDIATRIC BOARD EXAM IS A STANDARDIZED EXAMINATION ADMINISTERED BY THE AMERICAN BOARD OF PEDIATRICS (ABP) TO CERTIFY PEDIATRICIANS. THIS EXAM EVALUATES A CANDIDATE'S KNOWLEDGE, CLINICAL JUDGMENT, AND PROBLEM-SOLVING ABILITIES RELATED TO PEDIATRIC MEDICINE.
