- DISCUSSING POTENTIAL SIDE EFFECTS
- PROVIDING INSTRUCTIONS ON HOW AND WHEN TO TAKE THE MEDICATION
- ADVISING ON LIFESTYLE CHANGES THAT CAN ENHANCE MEDICATION EFFICACY

3. CRITICAL THINKING AND CLINICAL JUDGMENT

IN HIGH-PRESSURE CLINICAL SETTINGS, NURSES MUST MAKE QUICK DECISIONS REGARDING MEDICATION ADMINISTRATION. A SOLID GRASP OF PHARMACOLOGICAL PRINCIPLES SUPPORTS CRITICAL THINKING AND CLINICAL JUDGMENT, ALLOWING NURSES TO:

- ASSESS THE APPROPRIATENESS OF PRESCRIBED MEDICATIONS
- IDENTIFY ADVERSE REACTIONS OR COMPLICATIONS
- ADVOCATE FOR PATIENT SAFETY AND OPTIMAL THERAPEUTIC OUTCOMES
