- SOLUTION: BREAK THESE TOPICS DOWN INTO SMALLER PARTS. USE DIAGRAMS AND MODELS TO ILLUSTRATE PROCESSES LIKE ABSORPTION, DISTRIBUTION, METABOLISM, AND EXCRETION.
