

RESTORATIVE JUSTICE TRAINING ONLINE

4. COMMUNITY INVOLVEMENT: ENCOURAGING THE COMMUNITY TO PLAY A ROLE IN THE RESOLUTION PROCESS.

THE IMPORTANCE OF ONLINE TRAINING

WITH THE RISE OF DIGITAL LEARNING PLATFORMS, RESTORATIVE JUSTICE TRAINING ONLINE PRESENTS SEVERAL ADVANTAGES:

COMPONENTS OF RESTORATIVE JUSTICE TRAINING

2. CORE PRINCIPLES AND PRACTICES

- CONFERENCES: A MORE FORMAL MEETING THAT INCLUDES FAMILY MEMBERS, COMMUNITY MEMBERS, AND OTHER STAKEHOLDERS.

3. SKILLS DEVELOPMENT

A SIGNIFICANT PORTION OF THE TRAINING FOCUSES ON DEVELOPING PRACTICAL SKILLS NECESSARY FOR IMPLEMENTING RESTORATIVE JUSTICE PRACTICES, INCLUDING:

- ACTIVE LISTENING: TECHNIQUES FOR TRULY HEARING AND UNDERSTANDING OTHERS' PERSPECTIVES.
- FACILITATION: GUIDING DISCUSSIONS IN A NEUTRAL AND CONSTRUCTIVE MANNER.
- CONFLICT RESOLUTION: STRATEGIES FOR DE-ESCALATING TENSIONS AND FINDING COMMON GROUND.

4. CASE STUDIES AND ROLE-PLAYING

MANY ONLINE COURSES INCORPORATE REAL-LIFE SCENARIOS TO HELP PARTICIPANTS APPLY THEIR LEARNING. THIS MAY INVOLVE:
