UNDERSTANDING PEARSON VUE EXAM RESCHEDULING POLICIES

GENERAL RESCHEDULING GUIDELINES

CAN I RESCHEDULE A PEARSON VUE EXAM TO A DIFFERENT TEST CENTER?
