## FINANCIAL INFORMATION

THIS CATEGORY ENCOMPASSES QUESTIONS AIMED AT REVEALING INCOME SOURCES, EMPLOYMENT DETAILS, BONUSES, COMMISSIONS, AND OTHER FINANCIAL BENEFITS. ACCURATE FINANCIAL DISCLOSURES ARE ESSENTIAL FOR CALCULATING SUPPORT OBLIGATIONS AND DIVIDING MARITAL PROPERTY FAIRLY.

## PROPERTY AND ASSETS

QUESTIONS RELATED TO PROPERTY AND ASSETS SEEK TO IDENTIFY REAL ESTATE HOLDINGS, VEHICLES, BANK ACCOUNTS, INVESTMENTS, RETIREMENT FUNDS, AND PERSONAL PROPERTY. THE GOAL IS TO CREATE A COMPLETE INVENTORY OF MARITAL AND SEPARATE PROPERTY.

## CHILD CUSTODY AND VISITATION

## SAMPLE DIVORCE DISCOVERY QUESTIONS FOR FINANCIAL ISSUES

FINANCIAL ISSUES OFTEN CONSTITUTE THE MOST COMPLEX PART OF DIVORCE PROCEEDINGS. 1. PLEASE STATE YOUR CURRENT EMPLOYER'S NAME, ADDRESS, AND YOUR POSITION, INCLUDING YOUR LENGTH OF EMPLOYMENT.
2. LIST ALL SOURCES OF INCOME RECEIVED DURING THE PAST THREE YEARS, INCLUDING SALARIES, BONUSES, COMMISSIONS, DIVIDENDS, AND ANY OTHER EARNINGS.
3. IDENTIFY ALL BANK ACCOUNTS HELD INDIVIDUALLY OR JOINTLY, INCLUDING ACCOUNT NUMBERS, FINANCIAL INSTITUTIONS, AND CURRENT BALANCES.
4. PROVIDE DETAILED INFORMATION ON ALL REAL ESTATE OWNED, INCLUDING ADDRESSES, PURCHASE DATES, PURCHASE PRICES, AND CURRENT MARKET VALUES.
5. LIST ALL RETIREMENT ACCOUNTS, PENSIONS, OR PROFIT-SHARING PLANS IN WHICH YOU HAVE AN INTEREST, INCLUDING CURRENT BALANCES.
6. DISCLOSE ALL DEBTS AND LIABILITIES, SPECIFYING CREDITORS, AMOUNTS OWED, AND THE NATURE OF EACH DEBT.
7. PROVIDE COPIES OF YOUR FEDERAL AND STATE INCOME TAX RETURNS FOR THE PAST THREE YEARS.

## SAMPLE DIVORCE DISCOVERY QUESTIONS FOR CHILD CUSTODY AND SUPPORT

CHILD CUSTODY AND SUPPORT QUESTIONS FOCUS ON THE WELFARE AND NEEDS OF MINOR CHILDREN INVOLVED IN THE DIVORCE. 3. LIST ALL HEALTHCARE PROVIDERS, INCLUDING PHYSICIANS, DENTISTS, AND THERAPISTS, WHO HAVE TREATED THE CHILDREN IN THE PAST YEAR.

4. PROVIDE INFORMATION ON THE CHILDREN'S SCHOOLING, INCLUDING SCHOOLS ATTENDED, GRADES, AND ANY SPECIAL EDUCATIONAL NEEDS.
5. STATE THE APPROXIMATE MONTHLY EXPENSES FOR THE CHILDREN, INCLUDING FOOD, CLOTHING, EDUCATION, AND EXTRACURRICULAR ACTIVITIES.
6. DESCRIBE ANY PRIOR AGREEMENTS OR COURT ORDERS REGARDING CUSTODY AND VISITATION SCHEDULES.
7. IDENTIFY ANY HISTORY OF DOMESTIC VIOLENCE OR ABUSE INVOLVING THE CHILDREN OR EITHER PARENT.

## BEST PRACTICES FOR DRAFTING AND RESPONDING TO DISCOVERY QUESTIONS

RESPONDING PARTIES MUST ANSWER DISCOVERY QUESTIONS TRUTHFULLY AND COMPLETELY. OBJECTIONS SHOULD BE RAISED ONLY WHEN QUESTIONS ARE OVERLY BROAD, UNDULY BURDENSOME, OR IRRELEVANT. PROVIDING DETAILED, WELL-ORGANIZED ANSWERS SUPPORTED BY DOCUMENTATION STRENGTHENS CREDIBILITY AND REDUCES THE RISK OF COURT SANCTIONS. CONSULTING LEGAL COUNSEL IS ADVISABLE TO ENSURE COMPLIANCE AND PROTECT RIGHTS THROUGHOUT THE DISCOVERY PROCESS.

IN HIGH-ASSET DIVORCE CASES, DISCOVERY QUESTIONS SHOULD BE DETAILED AND SPECIFIC, SUCH AS: 'LIST ALL BUSINESS INTERESTS AND VALUATIONS.', 'PROVIDE TAX RETURNS AND FINANCIAL STATEMENTS FOR THE PAST FIVE YEARS.', AND 'DISCLOSE ALL RETIREMENT ACCOUNTS AND INVESTMENT PORTFOLIOS.'

## ARE DISCOVERY QUESTIONS IN DIVORCE CONFIDENTIAL?

DISCOVERY QUESTIONS AND RESPONSES ARE GENERALLY PART OF THE LEGAL PROCESS AND SUBJECT TO COURT RULES. WHILE THEY ARE NOT AUTOMATICALLY CONFIDENTIAL, PARTIES CAN REQUEST PROTECTIVE ORDERS TO KEEP SENSITIVE INFORMATION PRIVATE.
