FROM THOMAS MORE’S “UTOPIA” TO MODERN INTERPRETATIONS, THE VISION OF A PERFECT SOCIETY OFTEN REVOLVES AROUND SPECIFIC RULES THAT GOVERN THE BEHAVIOR OF ITS INHABITANTS AND THE STRUCTURE OF THE COMMUNITY ITSELF. RULES PROMOTING EQUALITY AND INCLUSIVITY
