VARIOUS TYPES OF SAFETY JUDGEMENT QUESTIONS OCCUPATIONAL THERAPY PROFESSIONALS USE TO ASSESS DIFFERENT ASPECTS OF SAFETY AWARENESS AND DECISION-MAKING. THESE QUESTIONS ARE DESIGNED TO SIMULATE REAL-LIFE SCENARIOS OR EVALUATE UNDERSTANDING OF SAFETY PRINCIPLES. COMMON CATEGORIES INCLUDE SITUATIONAL JUDGEMENT QUESTIONS, HYPOTHETICAL PROBLEM-SOLVING TASKS, AND DIRECT INQUIRIES ABOUT SAFETY PRACTICES.

## SITUATIONAL JUDGEMENT QUESTIONS

THESE QUESTIONS PRESENT PATIENTS WITH SPECIFIC SCENARIOS WHERE THEY MUST IDENTIFY POTENTIAL HAZARDS AND CHOOSE THE SAFEST COURSE OF ACTION. FOR EXAMPLE, A QUESTION MAY DESCRIBE A KITCHEN SITUATION INVOLVING A STOVE LEFT ON AND ASK WHAT THE PATIENT WOULD DO NEXT. THESE QUESTIONS ASSESS PRACTICAL JUDGEMENT AND HAZARD RECOGNITION.

## HYPOTHETICAL PROBLEM-SOLVING TASKS

HYPOTHETICAL QUESTIONS CHALLENGE PATIENTS TO THINK CRITICALLY ABOUT SAFETY-RELATED PROBLEMS AND DEVISE SOLUTIONS. FOR INSTANCE, A THERAPIST MIGHT ASK HOW A PATIENT WOULD RESPOND IF THEY NOTICED A SLIPPERY FLOOR OR IF A SMOKE ALARM SOUNDED. THIS TYPE OF QUESTIONING EVALUATES REASONING AND PLANNING ABILITIES.

## DIRECT SAFETY KNOWLEDGE QUESTIONS

THESE QUESTIONS TEST PATIENTS' EXPLICIT KNOWLEDGE OF SAFETY RULES AND PROCEDURES. EXAMPLES INCLUDE ASKING ABOUT THE IMPORTANCE OF USING HANDRAILS WHEN CLIMBING STAIRS OR THE STEPS TO TAKE DURING A FIRE EVACUATION. THIS APPROACH HELPS IDENTIFY GAPS IN BASIC SAFETY KNOWLEDGE THAT MAY IMPACT JUDGEMENT.

# ASSESSMENT TECHNIQUES FOR EVALUATING SAFETY JUDGEMENT

## STRUCTURED INTERVIEWS AND QUESTIONNAIRES

CONDUCTING INTERVIEWS WITH PATIENTS AND CAREGIVERS HELPS COLLECT SUBJECTIVE INFORMATION ABOUT SAFETY CONCERNS AND BEHAVIOURS. QUESTIONNAIRES FOCUSING ON SAFETY JUDGEMENT CAN REVEAL PERCEPTIONS OF RISK AND HIGHLIGHT AREAS NEEDING INTERVENTION.

# APPLICATIONS OF SAFETY JUDGEMENT QUESTIONS IN CLINICAL PRACTICE
