- NATURALIZED CITIZENS PLEDGE LOYALTY TO THE UNITED STATES DURING THE CITIZENSHIP CEREMONY.
- UNDERSTANDING THE HISTORY OF CIVIL RIGHTS MOVEMENTS HELPS CITIZENS APPRECIATE THE NATION'S VALUES.
- VOTING IN ELECTIONS IS A FUNDAMENTAL WAY FOR CITIZENS TO PARTICIPATE IN DEMOCRACY.
- THE SUPREME COURT INTERPRETS THE CONSTITUTION AND ENSURES LAWS COMPLY WITH IT.

## STRATEGIES FOR PRACTICING WRITING SENTENCES
